Only competitors and team officials holding a valid IFSC international license are allowed to register for the competition.

TEAM OFFICIALS AND COMPETITORS:

Member federations may register, within statutory deadlines, all their team officials who shall be granted free entry into the competition venue. These officials shall be registered via the <u>IFSC website</u>, must be in possession of a valid international licence and specifically nominated for one of the following roles:

a)One (1) team manager; b)Up to three (3) team coaches; c)Up to three (3) qualified medical or para-medical personnel.



TRAVELLING TO SOURE

Soure is located near Coimbra and about 150km of Porto airport and 180 km of Lisbon airport. It has a railway station and some trains from Porto, Lisbon and Coimbra stop there.

By plane: The nearest airports are: - Porto (157 km)

- Lisboa (177 km)

By train: From Porto or Lisbon you can catch a train to Soure Railway station, then take less than 10 minutes walk to the competition venue. It is possible to take a train from Porto or Lisbon to Coimbra and come to Soure by train or by bus.

By car: On motorway From Lisbon or Porto take A1: take the exit marked Soure. At the roundabouts take N348 to the right. After 6 km you are in centre of Soure.

COMPETITION FORMAT

The format for qualifications has been changed by the IFSC Europe Executive Board, in order to reduce the amount of people present at the Field of-Play at the same time:

Qualifications: 5 Boulders/4 Minutes (preparation time 15 seconds); Flash Mode (All boulders will be presented to the athletes by video) Finals: 4 Boulders/4 minutes (preparation time 15 seconds); Quota: 10/category.











ACCOMMODATION

Soure is a small village with few accommodations.

This year we made a special arrangement with Palace Hotel & SPA Termas do Bicanho (****), about 14Km from the venue. The hotel will provide about 136 rooms for the EYCup. The price includes breakfast. Usually the hotel does not provide meals but, for the European Cup, the teams can book for it.

It is possible to have free transportation between this hotel and the competition venue during the competition days, three times a day, in defined hours, depending of the competition final time table.

COVID RELATED INFORMATION

TECHNICAL MEETING: There will be an Online Technical Meeting on Wednesday, 13th of April 2pm (CET) primarily to discuss the Covid-19 regulations. Link to the meeting <u>HERE</u>.

PREVENTION MEASURES & PROCEDURE ON SITE Details regarding all Covid-19 related measures (prevention measures during the competition, warm-up procedure, testing,...):

Public is allowed but there are rules to follow:

- Mouth mask is obligatory at all times;

Exceptions

- Athletes during warm up (on the wall only)

- Athletes during competitions (on the wall only)

NECESSARY MEDICAL CERTIFICATE OF A NEGATIVE SARS-COV-2 TEST or EU Digital COVID Certificate

All athletes, coaches, officials and staff are required to have an EU Digital COVID Certificate or a valid negative Sars-Cov-2-Test result at registration. Rapid-Antigen Tests have a validity of 48 hours and PCR Tests have a validity of 72 hours. Both types of tests will be accepted.

- RT-PCR Test (or similar NAAT test) 72h before registration or
- Rapid Antigen Test 48h before registration, or
- a valid EU Digital COVID Certificate (the full vaccination should be at least 14 days old.) or
- a valid Vaccination or recovery certificate issued by a third country, under reciprocal conditions, dated and with an official stamp.

All test / vaccination certificates of all team members need to be written in Portuguese or English. All tests and certificates have to be sent to <u>testcovid@fpme.org</u> at last 4h before the registration.

HOW TO TRAVEL TO PORTUGAL:

The following information was written on April 11th, according to the Covid-19 restrictions valid at this time. If the travel restrictions change, the information will be updated as soon as possible.

1) Arriving to Portugal by Plane

ALLOWED AIR TRAFFIC

- Flights to and from European Union countries or a State associated with the Schengen Area (Liechtenstein, Norway, Iceland and Switzerland), Angola, Brazil, Cape Verde, Canada, United States of America, Guinea-Bissau, Mozambique, United Kingdom and Sao Tome and Principe:

- Flights from Saudi Arabia, Bahrain, Chile, Colombia, Indonesia, Kuwait, New Zealand, Peru, People's Republic of China, Qatar, Rwanda, Saudi Arabia, South Korea, United Arab Emirates, and Uruguay, as well as Taiwan and the administrative regions of Hong Kong and Macau

Flights to and from countries not mentioned are allowed exclusively for "essential travel", i.e. to allow the entry into Portugal of citizens travelling for professional, study and family reunion purposes, and for health or humanitarian reasons.













Travel, for any reason, to Portugal is also allowed by travellers with an EU COVID Digital Certificate - vaccination or recovery modes - or a digital certificate recognized by the European Commission, with a complete vaccination schedule, for more than 14 and less than 270 days, or with a vaccine booster.

Mandatory to present

- A valid vaccination <u>EU Digital COVID Certificate</u> (with a complete vaccination schedule or with a complete vaccination schedule and a vaccine booster);
- Or a valid test or recovery EU Digital COVID Certificate,
- Or a valid vaccination certificate (with a complete vaccination schedule or a vaccine booster) or recovery certificate issued by a third country, under reciprocal conditions
- Or a negative RT-PCR Test (or similar NAAT test) 72h before boarding,
- Or a negative Laboratorial Rapid Antigen Test- 24h before boarding (according to the European Commission list)

Accepted vaccination certificates issued by third countries under reciprocal conditions: Albania, Andorra, Armenia, Benin, Cabo Verde, Colombia, El Salvador, Faroe Islands, Georgia, Israel, Iceland, Jordan, Lebanon, Liechtenstein, Malasya, Moldova, Monaco, Montenegro, Morocco, New Zealand, North Macedonia, Norway, Panama, San Marino, Serbia, Singapore, Switzerland, Taiwan, Thailand, Tunisia, Togo, Turkey, Ukraine, United Arab Emirates, United Kingdom and the Crown Dependencies (Jersey, Guernsey and the Isle of Man), Uruguay, The Vatican (https://ec.europa.eu/info/live.work-travel-eu/coronavirus-response/safe-covid-19-vaccines-europeans/eu-digital-covid-certificate_en),

Accepted vaccines authorized by the European Medicines Agency - Comirnaty (BioNTech and Pfizer), Nuvaxovid (Novavax), Spikevax (Moderna), Vaxzevria (AstraZeneca), COVID-19 Vaccine Janssen (<u>https://www.ema.europa.eu/en/human-regulatory/overview/public-health-threats/coronavirus-disease-covid-19/treatments-vaccines/covid-19-vaccines</u>) - and Sinopharm (Vero Cell), Sinovac (Coronavac), Bharat Biotech International (Covaxin).

Vaccination certificates are accepted if they consider one of the vaccines approved in Portugal and according to the terms that you can consult in " ADDITIONAL INFORMATION / Vaccination" at pages 9 and 10.

- Children under 12 do not need to present certificate or test.
- It is mandatory for all passengers bound for mainland Portugal or in transit/transfer (including from Madeira and Azores) to fill online a Passenger Locator Form (individually) at https://portugalcleanandsafe.pt/en/passenger-locator-card, after check in and before departure time. The QR Code generated when filling out the PLF can be presented in paper or digital format, without which boarding will be denied.

2) Arriving to Portugal by Land

It is mandatory to present the EU COVID Digital Certificate. Citizens who are not holders of the Digital Covid EU certificate in vaccination, test, or recovery modalities, will have to present proof of a negative RT-PCR test (TAAN), performed in the last 72 hours, or rapid antigen test (TRAg), performed in the last 24h.

In the case of travel by land, each traveller must obtain information about the measures and restrictions existing in each one of the countries of transit, directly with their authorities.

3) Arriving to Portugal by Sea

Same rules as arriving by air apply.













All passengers need to fill online a Passenger Locator Form (individually) at https://portugalcleanandsafe.pt/en/passenger-locator-maritime.card, within 96 hours prior to the estimated time of arrival in mainland Portugal. The QR Code generated when filling out the PLF can be presented in paper or digital form.

GENERAL RULES

Mandatory mask in closed spaces;

Access without restriction to accommodation, restaurants, events, bars and clubs and other public spaces/services. The obligation to present a certificate or test was eliminated, except at border control, where the restrictions are maintained. Mandatory negative test or recovery certificate, except for those who have already been vaccinated with a booster dose of the vaccine for at least 14 days, only when visiting care and nursing homes and health facilities.

BEHAVIOR RULES

General behaviour guidelines

- Social distancing;
- Frequent hand washing;
- Respiratory etiquette.

ADDITIONAL INFORMATION

Essential Travel definition

"Essential travel" is defined as trips allowing the transit, entry into and departure from Portugal for professional purposes, study, family reunions, health and humanitarian reasons and under the reciprocity principle.

Tests

a. Controls might be undertaken upon arrival to airport:

- b. The test result must include:
 - type of test taken:
 - passenger name (as per passport);
 - date of birth:
 - clear identification of the laboratory including the certification:
 - the date and time the sample was collected and the explicit negative test result:
 - SMS is not a valid format

c. Passengers who present tests that do not comply with the requirements must undergo a new test on arrival, before entering Portuguese territory, at their own expense, and must wait in a designated place, inside the airport, until the result is notified.

d. If you are a foreigner visitor and want to do the test for Covid-19 shortly after arrival, before departure or at any time in Portugal you can do it: - at the Airport. Information at https://www.ana.pt/en/corporate/ana/faq;

- in a laboratory approved by the Portuguese Health General Directorate. Find the list at https://covidi.9.min-saude.pt/infoadrpcc;

- in one of the hospitals and clinics included in the Portugal Health Passport that can provide you personalized support in your language. The test for Covid 19 must be scheduled with a consultation and the results will be available in up to 72 hours. More information is available at test covid 19@portugalhealthpassport.com

Vaccination

The vaccination schedule is considered complete after taking:

a) From a single dose vaccine, for vaccines with a one-dose vaccine schedule:











b) The second dose of a vaccine against COVID-19 with a two-dose vaccine schedule, even if doses of two different vaccines have been administered; or

c) A single dose of a vaccine against COVID -19 with a two-dose vaccination schedule for people who have recovered from the disease, if it is indicated in the vaccination certificate that the vaccination schedule was completed after administration of one dose.

The vaccination schedule is complete 14 days after the last dose has been taken.

Accepted vaccines authorized by the European Medicines Agency - Comirnaty (BioNTech and Pfizer), Nuvaxovid (Novavax), Spikevax (Moderna), Vaxzevria (AstraZeneca), COVID-19 Vaccine Janssen (https://www.ema.europa.eu/en/human-regulatory/overview/public-health-threats/coronavirus-disease-covid-19/treatments-vaccines/covid-19-vaccines) - and Sinopharm (Vero Cell), Sinovac (Coronavac), Bharat Biotech International (Covaxin).

Vaccines accepted in Madeira Islands: Astrazeneca, Pfizer, Moderna, Johnson & Johnson/Janssen, Sinovac/Instituto Buntantan, Instituto Gambaleya (Sputnik V) and Sinopharm (VeroCell)

EU Digital COVID Certificate

The EU Digital COVID Certificate is a digital proof that a person:

Has been vaccinated against COVID-19, or

Has received a negative test result (NAAT test or Rapid Antigen test), or Has recovered from COVID-19.

* Children under 12 years old are exempt of presenting the EU Digital COVID Certificate or testing requirements

* It is valid for 270 days since the last dose has been taken, in a complete vaccination schedule.

Certificates issued by third countries, under reciprocal conditions Vaccination certificates must include:

- Given name(s) and surname(s) of the holder;
- Date of birth;
- Disease or agent targeted: COVID-19 (SARS-CoV-2 or one of its variants);
- Vaccine against COVID-19 or prophylaxis;
- Name of the vaccine against COVID-19;
- Marketing authorization holder or manufacturer of the vaccine against COVID-19:
- Number in a series of doses as well as the total number of doses in the series:
- Date of vaccination, indicating the date of the last dose administered
- Member State or third country where the vaccine was administered:
- Entity issuing the certificate.

Recovery certificates must include:

- Given name(s) and surname(s) of the holder;
- Date of birth:
- Disease or agent from which the holder recovered: COVID-19 (SARS-CoV-2 or one of its variants):
- Date of the first positiveresult of the diagnostic test:
- Member State or third country in which the diagnostic test was performed:
- Entity issuing the certificate:
- Valid certificate

Non-reciprocity in the recognition by third countries of the validity of the EU COVID Digital Certificate issued by Portugal, in the modalities of vaccination or recovery certificates, prevents the recognition of the validity of certificates issued by these third countries.
