All competitors and team officials must be in possession of an up-to-date IFSC license and must be registered through the IFSC online Registration System: <a href="https://ifsc.results.info/users/login">https://ifsc.results.info/users/login</a>

Team Quota (Rules 2022 European Climbing Competitions - IFSC Europe):

- 4.2.2 Member Federations may register, within statutory deadlines, Team Officials for one of the following roles:
- (a) One (1) Team Manager;
- (b) Up to two (2) coaches per discipline;
- (c) Up to two (2) qualified medical or paramedical personnel.
- 4.2.3 Member Federations may register up to four (4) competitors (and in the case of the host Member Federation, eight (8) competitors) for each Category in each relevant discipline.

#### **Competition format**

According to the Rules 2022 European Climbing Competitions - IFSC Europe

Registration fees: Euro 25,-

Fee to be paid for every athlete per discipline.

The registration fee will be invoiced by IFSC Europe to the national federations. No cash-payments will be done on site.

For the registration on Friday 29th of April, it is necessary for all team managers to show the passports or ID-cards of their competitors (or copy).

#### **COVID RELATED INFORMATIONS**

As of 15.3. 2022 the <u>following obligations</u> are valid: to have respiratory protection in medical facilities, social facilities and public transport, this obligation applies with exceptions.

All athletes and team officials are recommended **to have insurance coverage**, covering hospitalization and all other medical coverage if required due to COVID-19 and possible repatriation back to their home country.

The CMA and the IFSC Europe will not be responsible for any of these costs

#### **Competititon under Covid - 19**

During the registration all team members will have to present mandatory:

- Valid negative RT-PCR Test 72 hrs. before registration or
- Valid negative Rapid Antigen Test 48 hrs. before registration, or
- a valid EU Digital COVID Certificate (the full vaccination should be at least 14 days old) or
- a valid Vaccination or recovery certificate issued by a third country, under reciprocal conditions, dated and with an official stamp.

All test / vaccination certificates of all team members must be written in Czech or English. For checking the test/vaccination certificates will be enough the scan in your mobile.

The competition will be held under the regulation of the IFSC Addendum

#### **Travel informations under Covid - 19**

Current coronavirus information and recommendations for foreign visitors can be found on the website of the Ministry of Foreign Affairs of the Czech Republic

#### **ENTRY CONDITIONS**

- 1) All travellers must fill out a Passenger Locator Form before arrival.
- 2) Upon entry, all travellers must present one of the following:
- → vaccination certificate (The full vaccination should be at least 14 days old.

As of 1 February 2022, there are new rules in place that establish a binding acceptance period of 9 months for vaccination certificates.) OR

- → certificate of recovery from Covid-19 OR
- → negative PCR test not older than 72 hrs. OR
- → negative AG test not older than 24 hrs.
- 3) Travelers who arrive from non-EU countries must get tested with a PCR method 5th 7th day after arrival (if their stay is not shorter).

Note: If you are travelling by individual transportation (such as own car) and you are at the same time an EU citizen, family member of an EU citizen or resident in the EU, the entry rules stated above do not apply to you.
