3. TRAVEL & VISA

Arrival by car

Mezzolombardo is about 20 minutes from Trento, the capital of the autonomous province of which it is part. By car can be reached through the A22 Brennero (Brennero-Modena), exit S.Michele – Mezzocorona (2,90 km from the center of Mezzolombardo) or exit Trento Nord (10,77 km from the centre).





Arrival by train

The station of Mezzolombardo is the railway station of the R35 Trento-Malé-Mezzana line.

Arrival by plane

The closest airport to Mezzolombardo is the Bolzano/Bozen (BZO) airport, 39.7 km far from the city. Other nearby airports are Verona (VRN) (91.1 km), Milan Bergamo (BGY) (123.7 km), Venice (VCE) (124.5 km) e Milan Linate (LIN) (163.5 km).

6. TEAM QUOTAS & RULES

REGISTRATION OF TEAM OFFICIALS AND COMPETITORS:

Only competitors and team officials holding a valid IFSC international license are allowed to register for the competition and must be registered through the IFSC registration system.

According to IFSC-Europe Rules 2.2.2, Member Federations may register, within statutory deadlines, their team officials (who shall be granted free entry into the competition venue) for a maximum of:

- one (1) Team Manager;
- three (3) coaches per discipline;
- three (3) qualified medical or paramedical personnel.

According to IFSC-Europe Rules 2.2.3, Member Federations may register as competitors:

- up to three (3) competitors for each Category;
- the host federation shall be entitled to register an additional two (2) competitors in each Category.

11. COVID RELATED INFORMATION

Almost all the obligations inherent to the general use of the mask and possession of the Green Pass expires, but the Order of the Ministry of Health dated April 28, 2022 provides for the continuation of the obligation to wear FFP2 masks until June 15, 2022 in the following cases in aircraft; in ships and ferries used for interregional transport; in trains used for interregional, Intercity, Intercity Night and High Speed passenger rail transport services; in all buses and vehicles used for local public transport or between several regions; in all shows, events and sports competitions open to the public that take place indoor.

ENTRY CONDITIONS

As of June 1, 2022 a Green Pass or equivalent certificate is no longer needed to enter Italy. All Covid-19 related entry restrictions have been lifted. Limited containment measures remain in place in Italy, until June 15, 2022:

It is mandatory to wear FFP2 type respiratory protective equipment in the following cases:

- (a) for access to and use of the following means of transport:
 - 1) aircraft used for commercial passenger transport services;
 - 2) ships and ferries engaged in interregional transport services; and
 - 3) trains used in interregional, Intercity, Intercity Night and High Speed passenger rail transport services;
 - 4) Buses and coaches engaged in passenger transport services, of an undifferentiated nature, operated on a continuous or periodic basis by road on routes linking more than two regions and having fixed routes, timetables, frequencies and prices;
 - 5) buses used for rental services with driver
 - 6) vehicles used in local or regional public transport services;
 - 7) means of school transport dedicated to primary, lower secondary and upper secondary school students;
- b) for shows open to the public that take place indoors in theatres, concert halls, cinemas, entertainment and live music venues and other assimilated premises, as well as for sports events and competitions that take place indoors.

In addition, it is mandatory for workers, users and visitors of health, social and health care facilities to wear respiratory protection devices.

It is recommended to wear respiratory protective equipment in all indoor public places or places open to the public.

The following are exempt from the requirement of wearing respiratory protective devices: a) children under six years of age; b) people with pathologies or disabilities that are incompatible with the use of the masks, as well as people who must communicate with a disabled person in such a way that they cannot use a mask; c) people who are doing sports.
