#### **Delayed Arrival**

#### Confirmation of attendance

Team Managers are required to confirm the attendance of all athletes in their team. Individual athlete confirmation is permitted where no Team Manager has been registered for the competition. The location and schedule for confirmation of attendance is set out in chapter 10 and 13. Athletes not confirmed by the deadline as attending will be removed from official starting lists.


# IFSC Oceania Qualifier 2023

# **Qualification System**



INTERNATIONAL FEDERATION OF SPORT CLIMBING

Approved 1 November 2022 Updated 9 October 2023





















#### 1. Athlete eligibility

Athletes must hold an IFSC Licence and be registered through the IFSC registration system.

Selection policies for each country will be decided by their National Federation.

Athletes from Australia, New Zealand and Guam are eligible to compete at the event.

According to the <u>requirements</u> outlined by the National Olympic Committee of Guam, a series of eligibility criteria should be met by the international Guam athletes. Therefore, the Guam NOC shall send to the IFSC office (<u>office@ifsc-climbing.org</u>) a letter of confirmation for the athletes registered in the IFSC result system. The letter of confirmation shall be sent by **4**<sup>th</sup> **of November 2023**, and it should include confirmation of eligibility criteria for the selected athletes.

If the IFSC office will not receive the above letters by the deadline, the athletes will not be allowed to compete on the IFSC Oceania Qualifier.

#### 2. Quotas

Each eligible National Federation may select and register up the following athlete quotas for the event:

#### <u>Speed</u>

Australia	25	25
New Zealand	25	25
Guam	25	25

#### Lead Boulder Combined


Country	Male	Female
Australia	9	9
Guam	2	2
New Zealand	9	9

In the case that all quota places are not taken up, the surplus positions will be reallocated in these ratios until all places are filled.

Places cancelled or withdrawn after registration closes will be reallocated at the discretion of the event organiser up until seven days prior to the commencement of the event.
