

2.3. Confirmation of Attendance

Confirmation of attendance is mandatory for each discipline and must be done in person by the Head of Delegation. In case a National Team did not register the Head of Delegation, another member of the National Team shall be appointed to confirm attendance of the Team. In case of emergencies and late arrival, the Event Delegate must be informed immediately. Failure to provide this information in a timely manner may result in the athletes not being permitted to compete. A digital copy of the athletes' passports shall be provided at the confirmation of attendance.



3. Deadlines and quotas

3.1. Registration deadline

The deadline for registration is 42 days before the first day of competition (the “Registration Date”) on **April 3rd at 11.59PM UTC+0**

3.2. Valid athletes' international licence

Only competitors and team officials with a valid World Climbing international license and approved medical status are allowed to register for the competition.

Scheduling Visa Appointments:

- If an applicant is not able to schedule a visa appointment before their date of travel, they can request an expedited appointment. To request an expedite, the applicant must first schedule a regular appointment (even if it is beyond the



date of travel), and then re-enter the scheduling system and select the "Request Expedite/Emergency Appointment" option.

- When requesting an expedite, applicants must clearly explain their reason for travel and dates of travel to the U.S.
- Applicants can also consider applying in a third-country location with shorter wait-times. There is no penalty for applying anywhere appointments are available, even outside one's home country.

4.3. Travel information

Salt Lake City International Airport (SLC) is approximately 16 miles from Momentum – Fort Union and 7.5 miles from the USA Climbing National Training Center.

- By car: Approximately 20 minutes from Momentum – Fort Union.
- By Utah TRAX: Take Green line of the Utah TRAX from Airport Station to Courthouse Station (450 S Main St, Salt Lake City, UT 84101), then transfer to the Blue Line and take to Midvale Fort Union Station (7250 S 180 W Midvale, UT 84047) - approximately 2.4 miles away from Momentum – Fort Union.


Tickets for the event can be purchased on the USA Climbing Eventbrite [here](#) and will be needed for the following rounds:




